From 01 Oct 2018 to 30 Sep 2021 1.63% of the value of the GLOBAL IP OPPORTUNITY FUND Class B5 was incurred as expenses relating to the administration of the financial product. 0.11% of the value of the financial product was incurred as costs relating to the buying and selling of the assets underlying the financial product. Therefore 1.74% (Total Investment Charge) of the value of the financial product was incurred as costs relating to the investment of the financial product.

FUND MANAGER COMMENTARY

As October was drawing to a close and local government elections were coming closer, it was interesting to note the extent of voter apathy. South Africa is not yet a confident land again. We expect the (delayed) Medium-Term Budget Policy Statement to be cautious, mitigating some of the worry that the long end of the bond curve could lift again. Nevertheless, in the yield curve we have seen bear flattening over the past two months as inflation worries have persisted. It may be a time to prefer equities.

More widely, equity markets delivered a turnaround in performance for October as the realisation set in that real rates were not going to turn positive anytime soon. Investors had been rather myopically focused on breakeven inflation rates quickly becoming less negative and began to discount interest rate rises as early as November. What investors seem to have missed during September was that negative real interest rates have become – at least for now – part of central bank policy in the developed world. Central banks are invested in ensuring that increasing interest costs do not dampen growth too much as we move into 2022. Earnings surprises from the S&P500 added fuel to the sharp recovery.

Growth around the world will slow as we move into 2022 even as inventory is accumulated and there are fewer supply shortages. The inflection point in the global interest rate cycle is likely to be coincident with a change in employment patterns towards full employment. At this point real interest rates will start to rise as break-even inflation rates, paradoxically, begin to fall.

Against this background we are pleased to report a solid month for your portfolio.


INVESTMENT THEME & REVENUE DRIVERS

Within the current macro environment we remain focused on those companies that are adaptive to a very rapidly changing environment and who are able to survive. Those that don't will unquestionably flounder, with the downside to shareholder value and drawdown risk at asset class level being much greater than many expect. In this context we see companies in the consumer staple, healthcare, technology, consumer discretionary and industrial sectors as the primary drivers of this fund. We see these industries as demonstrating the sort of earnings power we are looking to invest in. In investing in these industries and the companies chosen for the fund, we look to establish a position in the leading players coupled with positions in stocks within the sector that may have a more specialist focus. The assessment of free cash flow, balance sheet strength and margin stability form an important part of the research process. Our assessment of value is based on the degree to which the market has priced in future growth prospects where our investment horizon is typically the next 12 to 36 months. In terms of geographic diversification, our preference at the moment is the US where we see the Fed's policy of accommodative monetary as an underpin to equity values as the economy transitions from central bank support to real earnings growth.
